CONSTRUCTION OF FENCING AT THE MASON RIVER PROTECTED AREA

(ST. ANN AND CLARENDON)

PROJECT: A Jamaican Path from Hills to Ocean

LOCATION: Jamaica

BACKGROUND

The Jamaican Path from Hills to Ocean project is jointly funded by the European Union Global Climate Change Alliance Plus (€4.9 million -J\$859.5 million), and the Government of Jamaica (€ 1.1 million-J\$193.0 million). The Hills to Ocean project which is being implemented over 5 years, began in November 2020. The Executing Agency of the project is the Planning Institute of Jamaica in collaboration with Implementing Partners, the Ministry of Agriculture, Fisheries and Mining, particularly the Rural Agricultural Development Authority and the Public Gardens Division, and the National Environment and Planning Agency.

The PIOJ is seeking Expressions of Interest (EOIs) for Construction of Fencing at the Mason River Protected Area (St. Ann and Clarendon).

1. NATURE OF WORKS

The Bills of Quantities is attached to this Request for Expression of Interest.

2. IMPLEMENTATION PERIOD OF TASKS

Six (6) months

3. SELECTION CRITERIA

a) Economic and financial capacity of candidate:

- the average annual turnover of the tenderer **in the past 3 years** must be at least 75% of the value of the tenderer's offer.
- the tenderer must have access to an amount of credit which exceeds 75% of the value of the tenderer's offer.

(b) Technical and professional capacity of candidate:

(b) i – Technical Capacity

- a. The tenderer must have completed as prime contractor at least one (1) project of the same nature or amount or complexity **as the works concerned** by the tender and implemented during the following period: **five (5) years** counting from the submission deadline please specify the dates. The project must be accompanied by a copy of the final acceptance of satisfactory completion of works certificate, signed by the supervisors/contracting authority of the projects concerned.
- b. The tenderer must carry out a least 75% of the contract work using its own resources, which means that it must have plant and human resources necessary to carry out that percentage of the contract.



(b) ii- Professional Capacity

- (a) Current certification by the Government of Jamaica as a Grade 1-3 Contractor.
 - (b) Key staff must demonstrate a minimum number of years of appropriate and proven qualification relevant to works of a similar nature to this project as follows:
 - i. One (1) - Supervisory staff with at least 4 years of experience in the industry
 - ii. One (1) - Technical staff with at least 2 years of experience in the industry, particularly masonry and carpentry
 - (c) a statement of the technical equipment, tools or the equipment and facilities available to the operator for performing the works contract;
 - (d) a description of the **technical facilities** and means available to the economic operator for **ensuring quality work outputs**;
 - (e) a reference to the technicians or technical bodies available to the economic operator, whether or not belonging directly to it, especially those responsible for **quality control**;
 - (f) a statement of the average annual manpower and the number of managerial staff of the economic operator **for the last five (5) years**;
 - g) an indication of the environmental management measures that the economic operator will be able to apply when performing the contract, including traffic management and control of dust nuisance.
