This competition invites primary and secondary school students to showcase their understanding of Jamaica's sustainable development journey through creative expression. Winning entries will be featured in Jamaica's official Third Voluntary National Review (VNR) report to the United Nations.

Jamaica's Young Voices: Sustainable Development Goals Creative Expression Competition is a nationwide initiative by the Planning Institute of Jamaica (PIOJ) in partnership with e-Learning Jamaica. The PIOJ acts as the data controller and will handle all personal information in accordance with applicable data protection laws. No personal data beyond what is necessary for programme administration and recognition will be collected or disclosed.

All schools, through the Principal will be required to confirm that they have obtained written consent from the parent or legal guardian of each participating student. The consent shall be for the use of the student's name, age, image, school name, and artwork in promotional materials, publications, and recognition events related to the programme. Parents or guardians may withdraw consent at any time prior to the submission deadline by notifying the school in writing or via email to privacy@pioj.com. Competition Guidelines:

For Track One (Cover Design):	• Submit original artwork in digital format (high resolution scan or digital creation) size 11" x 17" • Accepted formats: JPEG, PNG (not transparent) in the maximum file size (no compression) • Include a brief written explanation (100–300 words) describing your design and how it represents Jamaica's SDG journey • Artwork should be suitable for a professional publication cover.
For Track Two (Vision Stories)	Primary Division: 300-600 words Lower Secondary Division: 600–1,000 words Upper Secondary Division: 1,000–1,500 words • Submit in PDF format • Stories should be original, creative, and demonstrates understanding of SDG themes • Include a brief author biography (50 words max)
General Requirements for All Submissions:	• All work must be original and created by the student. Teacher guidance is encouraged • Include student's full name, grade, school, and contact information • Include teacher's name and contact information • Submissions must be in English • Work should reflect Jamaican context and experiences and articulate well-reasoned visions for Jamaica's future with deeper exploration of complex issues.
