The Government of Jamaica (GOJ) has received a grant through the World Bank (WB) under the Pilot Programme for Climate Resilience (PPCR) toward the cost of implementing the Improving Climate Data and Information Management Project (ICDIMP). The objective is to improve the quality and use of climate related data for effective planning and action at the local and national levels. A portion of the proceeds of this grant will be for a consultancy to undertake the Climate Change Knowledge, Attitude and Behavioural Practices (KAP) Survey.

The objective of the consultancy is to design and conduct a KAP survey to be compared to the 2012 baseline from the 2012 KAP survey. The results will be used to assess changes in climate change knowledge, attitude and practice and the contribution of the campaign under the Climate Change Education and Awareness towards Behavioural Change in Jamaica component of the ICDIMP. The survey will assess if there have been changes in the capacity for climate change adaptation at the individual, community and organisational levels.

The Planning Institute of Jamaica now invites eligible firms to indicate their interest in providing the consultancy services. Interested firms should provide detailed information demonstrating the required qualifications and relevant experience to perform the services (description of similar assignments undertaken). The shortlisting criteria are:

- The team lead should possess a post-graduate degree in economics, statistics, sociology or relevant branch of social sciences with five years' experience in the design and conduct of surveys (including quantitative and qualitative methods) or a first degree in the Social Sciences with specialized training in development communication, knowledge, attitude and behavioural practice surveys, and a minimum of seven (7) years' experience in the design and conduct of surveys (including quantitative and qualitative methods)
- Team members should possess general education, training and experience in the design, conduct and analysis of surveys of other team members (Researchers and Data Collectors)
- Training and experience in the design, conduct and analysis of KAP Surveys
- Experience in undertaking assignments of similar type, size and complexity
- Knowledge and experience in Climate Change issues within Jamaica and the Caribbean

The attention of interested consultants is drawn to paragraph 1.9 of the World Bank's *Guidelines: Selection and Employment of Consultants [under IBRD Loans and IDA Credits & Grants] by World Bank Borrowers* dated January 2011 revised July 2014 ("Consultant Guidelines"), setting forth the World Bank's policy on conflict of interest.
